1. Operator must have valid driver's licenses
2. All North Carolina Driving Laws apply - i.e. car seats, mobile phone usage, seatbelts, littering.
3. Operate only on public roads within Town limits with posted speed limits of 35 mph or less.
4. Vehicle must be equipped with: headlamps, stop lamps, tail lamps, Minimum of 2"X12" strip of reflector tape on driver and passenger sides of the Golf Cart, parking brakes, rearview mirrors, windshields, seat belts, and a vehicle identification number.
5. Vehicle must be registered and insured.
6. Do not cross at any street intersection at NC Hwy 109 unless it is controlled by a stop light.
7. Do not drive on sidewalks.
8. Vehicle must be inspected by the Denton Police Department annually.
9. Vehicle must have a visible "Town of Denton Golf Cart Permit" sticker. Purchase your annual sticker at Town Hall for \$5.00. To purchase sticker, you must have a completed and signed inspection form from the Denton Police Department.

Violation of these rules shall subject the violator to penalties and remedies, either criminal or civil or both, as set forth in the Code of Ordinances of the Town of Denton.

The full Low-speed Vehicle Ordinance document and the North Carolina General Statutes are available at Town Hall.

- I furthermore ensure that I will obey all the rules and regulations set forth by the Town of Denton and the State of North Carolina concerning the operation of a Cart or SMV within the town limits. I agree to indemnify and hold harmless the Town of Denton for any and all liability arising from the use of this golf Cart/SMV.
- **I also understand that the Denton Police Department's interpretation of all the rules and regulations are final.**

Golf Cart registration stickers are to be placed on the driver's side of the cart at all times.
